This consignment agreement is entered into as of the date set forth below by and between As They Grow, Inc (As They Grow) and the individual listed below (Consignor). All consignments of clothing or other items are subject to the terms and conditions set forth below. As They Grow reserves the right to refuse consignment of any items. By your signature below you indicate your agreement to the following terms. This is a binding and valid legal contract.

- ❖ All consignment items must be in new or like-new condition
 - **Clothing:** All clothing items must be free of imperfections such as rips, tears, pulls or pills. All clothing and clothing accessories must be washed and free from smoke, stains or pet hair. All clothing items must be laid flat or folded in a tote, box or basket. All clothing sets must be folded together, do not pin or tape items together. Items in plastic bags will not be accepted. Imperfect items will not be accepted.
 - **Non-Clothing Items:** All toys, accessories and furniture must be in good, working condition with no missing items or pieces. All battery operated items must have working batteries or a battery fee (\$0.25 each battery) will be deducted from your account. All items must be cleaned, if item is not cleaned a cleaning fee (up to \$1.00) will be deducted from your account for each item.
- ❖ Items for consignment are taken by appointment only and priced at the discretion of As They Grow. Any items not accepted for consignment must be picked up by the consignor within 2 business days or the items will become property of As They Grow and will be donated/used/disposed at the discretion of As They Grow. Any items found to have a defect, after being placed on the sales floor, will be immediately removed and disposed of. **Please call As They Grow 3-4 weeks after you drop off items to see when your items expire. 845-7999**
- ❖ All items under \$28.99 is consigned on a 60/40 (store/consignor) basis. All items priced higher than \$28.99 are consigned on a 50/50 basis. Your account will be credited 40% of the final sales price, not including sales tax or item fees, at the time of sale.
- ❖ Consignors may take up to \$50 cash out of their account per day, if more money is requested from consignor account please call the store 2 days prior to picking up over \$50. If a check is requested a \$1.00 handling fee will be applied.
- ❖ Items will remain on the selling floor for no less than 45 day, at which time the items will be reduced by 25%. After 60 days the item will be reduced by 50%. At the 70th day the item will be reduced by 70%, at that time the consignor will have 5 days to contact As They Grow to pick up their unsold items. If you choose to pick up your items before the 70th day you will be charged a \$1.00 administrative fee per item.
 - Items may be reduced for clearance at the discretion of As They Grow at any time.
- ❖ It is the responsibility of the consignor to return to the store and collect any items that have not been sold, if the consignor desires such items be returned. The consignor must call the store 2-3 days prior to picking up unsold items so we can pull the items off the floor. **Any items not claimed at the conclusion of the consignment period will become property of As They Grow.**
- ❖ As They Grow does its best to protect all items on consignment. As They Grow, however, is not responsible for damage or loss caused by (but not limited to) theft, fire, flood or other accidental damages.
